## **AGREEMENT OF RULES FOR AFTER-SCHOOL DROP-IN PROGRAM**

This Agreement of Rules (Agreement) is between the person or persons signing this Agreement ("You" or "Your") and Stevens Family Taekwondo. You agree to all the terms and conditions, both written and printed, of this Agreement.

### **WE ARE NOT A DAYCARE NOR DO WE PROVIDE PRIMARY INSURANCE**

#### **SCHOOL RULES**

- Students are required to attend class daily
- No running or horse playing
- All personal items should be placed in designated areas
- Uniforms are to be worn to class each day
- No items should be left in the dressing rooms
- Uniforms and all other clothing should be brought home after class
- Keep your hands and feet to yourself
- Students are responsible to clean up after themselves
- All students are expected to work towards the completion of their homework each day
- No arguing with each other or any Adult
- Knock on the office door before entering
- You are responsible for your own items
- The school is not responsible for lost items
- Eat only in designated area
- Do not leave food and/or drink unattended
- Socks should be put in shoes and placed in the designated area

#### **VAN RULES**

- No yelling at any time! Use your inside voice while inside the van
- Stay seated and buckled up with your seatbelt until instructed not too
- Any child 8 years of age or under is required to be in a booster seat
- Do not turn around in your seat
- No food, drink or gum inside van
- Keep your feet off the seat in front of you

**NOTE TO PARENTS**

- Please call Stevens Family Taekwondo at 893-5304 or 406-3606 as early as possible if your child will be absent from after-school pick-up
- If your child is absent one or two days during the week, full payment for the week is still due.
- If your child is absent over half the week, we will prorate the payments for that week.
- Payment for the after-school program is not due if school is not in session.
- To keep traffic and study area open, we ask that all parents wait in the front area of the school after making a staff member aware of your child(s) pick-up.
- We reserve the right to dismiss anyone from our program for not following rule and regulations.

*A copy of your child's insurance card is required. We do not provide insurance for your child.*

I have read and agree to the Terms and Conditions of this Agreement and I further agree and understand that my child(ren) can and will be removed from the program if all of the above rules are not complied with. I further agree to hold Stevens Family Taekwondo (hereinafter called "SFTKD") and/or any of its nominees, harmless from and against any and all liability as to any problems that could arise. Regardless of fault, SFTKD is not responsible for loss of, or damage to, any property left behind by my child. You hereby assume all risk of such loss or damage and agree to defend, indemnify and hold SFTKD harmless from all claims. I understand and agree that I will pay for all costs and/or expenses of any kind for damages that may be caused by my child.

I agree that my insurance coverage, if valid and collectable, will be primary and responsible for handling, defending and paying all third-party claims, if any, should they arise. SFTKD does not provide you or your child with any type of insurance coverage.
